We, the undersigned natural persons of ~~the~~ age of
twenty-one years or more, at least two of whom are citizens of
the State of Texas, acting as incorporators of a corporation
under the Texas Non-Profit Corporation Act, do hereby adopt
the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is SHARPSTOWN CIVIC
ASSOCIATION, INC.

ARTICLE TWO

The corporation is a non-profit corporation.

ARTICLE THREE

The period of its duration is perpetual.

ARTICLE FOUR

The purpose or purposes for which the corporation is
organized are:

To preserve the property values, the environment and
ecology of the Sharpstown subdivisions of the City of Houston,
Harris County, Texas, and the surrounding area, and to promote
the civic, cultural and general welfare of the residents
thereof.

ARTICLE FIVE

The number of directors constituting the initial board of directors of the corporation is sixteen (16) and the names and addresses of the persons who are to serve as the initial directors are:




