6:30 P.M. - ROLL CALL Quorum was met.

- 1. Director Matt Wine, President, called the meeting to order at 6:30 PM.
- 2. Safety Update from Captain Eatmon. Thefts are up from the previous months.
- 3. Receive Appeals Relating to Deed Restriction Violations and/or Architectural Control Issues: NONE.
- 4. PUBLIC COMMENTS: Pat Menville reported that the SCAN added one new Associate membership and one new advertiser.
- 5. MINUTES: Director Schwartz-Hill submitted the minutes for adoption. All voted in favor to adopt the minutes.
- 6. COMMITTEE REPORTS:
 - COMMUNICATIONS REPORT: President Wine reported that HISD is putting together an artwalk with one possible location being PlazAmericas.
 - Director LeBlanc provided the board with a recap of the expenditures associated with the Americana Festival and general expenditures up through June 2019. The financial report up through July 2019 will be forthcoming.
 - MEMBERSHIP: Director LeBlanc informed the board that 289 previous members did not pay in 2019 which represents about \$66,745.00.
- 7. OLD BUSINESS:
 - Director Cowan presented a draft driveway policy and commentary. Tabled indefinitely.

- 8. NEW BUSINESS:
 - Director Cowan requested that a payment plan option be added to the SCA's website for voluntary dues.
 - Director Cowan inquired as to the possibility of moving the SCA's fiscal year end to June from December.
- 9. EXECUTIVE SESSION DEED RESTRICTIONS COMMITTEE REPORT: Director Schwartz-Hill presented the following matters for possible legal action (additional information redacted due to executive session):

 - Update on Deed Restriction Amendment Project
 - Recap that the Board has proposed no raises of the proposed dues until the year 2025.
 - Director Wine presented a list of questions to present to the association's attorneys including addressing what CPI is, the possibility of presenting a sample budget, education piece on special assessments, and addressing issues with regard to lot size.
 - Director Cowan suggested codifying a collections policy.
