

Minutes

- Director Matt Wine, President, called the meeting to order at 6:40 p.m.
- APPEALS Relating to Deed Restriction Violations or Architectural Control Issues: NONE
- PUBLIC COMMENTS: NONE.
- MINUTES: Matt Wine presented minutes of the April meeting previously distributed to Directors for their review. Dale Davidson made a motion that the April minutes be approved; Elizabeth Schooler seconded the motion, and it passed.
