

#### DEFINITIONS OF CRIME TYPES

Robbery — the taking of money or goods in the possession of another, from his or her person or immediate presence, by force or intimidation.

**Burglary** — (breaking and entering) an unlawful entry into a building for the purposes of committing an offence. Usually that offence is theft.

Theft — the act of stealing; the wrongful taking and carrying away of the personal goods or property of another; larceny. Examples include ransacking unlocked cars, taking property out of open garage doors, taking a purse off a front seat of an unlocked car, taking a mower out of the back of a pickup truck.

Aggravated Assault — an attempt to cause serious bodily injury purposely.

Property Crime — destruction, damage, vandalism

Rape — unlawful sexual activity carried out against the will of a male, female, or person under age, or incapable of consent.


### HPD HALLOWEEN ACTIVITIES

#### DO YOU KNOW YOUR **DEED RESTRICTIONS?**

Remodeling your home? Adding On? Do you know your deed restrictions? Did you know that the Sharpstown Civic Association can look over your proposed plans for free before you start construction? We want to avoid deed restriction violations before they happen. Did you know that we have a 25 foot rear setback for the main structure? Did you know that there is a minimum percentage of brick that must be on your home? Did you know that you can't build in front of your building line? We want to help you! We want you to find out about possible violations before it costs you money and time. Several homeowners in the past couple years have had to tear down and/or modify their construction due to deed restriction violations. The City of Houston does not review deed restrictions when issuing permits. They require a signed affidavit acknowledging that the plans comply with your deed restrictions. This holds YOU, the homeowner, accountable for knowing and complying with your deed restrictions. We are here to help you. # PUT THE DISTRICT J PATROL TO WORK FOR YOU!

If you haven't already heard about the District J Patrol, listen up! As the Patrol approaches its 1-year anniversary, we want to see our communities take advantage of this exciting new tool to combat area problems. The Patrol is a unique community-based approach to address the quality-of-life issues that can plague a neighborhood such as heavy trash violations, prohibited yard parking, illegal dumping, inoperative vehicles stored on the street, and more.

The Patrol only operates within District J so these specially-trained DRT officers spend their time within our neighborhoods, not spread out across the city. They work closely with all HPD branches including the Gang and Narcotics Divisions, as well as with other City functions such as the Department of Neighborhoods and Homeless Initiative.

What's missing? YOU ARE! When you see something, say something by going to DistrictJPatrol.com and clicking on "Report an Issue". Complete the requested information and your report will be sent to the DRT officers at South Gessner, Midwest or Westside Division depending on the address reported. While you are on the website, click on "View Status" to see the problems and resolutions already reported throughout the District. As your report is processed by HPD, their findings and results will be shown in this way too.

Creating stronger communities requires effort from all of us, so please join your neighbors as a voice for positive change.

#### TREES OF SHARPSTOWN

Sharpstown has many beautiful trees that were planted when the neighborhood was being built. The Sharpstown Parks Alliance would like to identify some of these trees in coming issues. Today's tree is this magnificent Magnolia tree.

The Magnolia is an ancient tree, as some fossilized specimens have been found dating back 95 million years ago. Its appearance before the evolution of bees leads some to theorize that it developed to encourage pollination by beetles. Today, there are many species of magnolias, some of which are deciduous.

What we think of as the Southern Magnolia can look great in your yard, but this tree should not be planted in an easement, as this is one of the types of trees whose roots

can lift the sidewalk. There are, however, smaller magnolias that don't create this problem, so be sure of the species before choosing to buy this tree.

## WHY IS CRIME AN ISSUE?

Last year and this year have seen a significant increase in attention paid to individuals out on felony bail. With the topic in the public interest, here is a look at the number of individuals out on felony bail, and what judges are supposed to consider when assessing bail. Information for this article comes from the district attorney's office answering public information act requests.

The considerations for assessing bail are found in the Texas Penal Code. The Penal Code sets forth a five prong test, with no instructions on how the prongs are to be weighed. This gives the individual judges significant latitude when setting bail. The code reads:

Art. 17.15. RULES FOR FIXING AMOUNT OF BAIL. The amount of bail to be required in any case is to be regulated by the court, judge, magistrate or officer taking the bail; they are to be governed in the exercise of this discretion by the Constitution and by the following rules:

- 1. The bail shall be sufficiently high to give reasonable assurance that the undertaking will be complied with.
- 2. The power to require bail is not to be so used as to make it an instrument of oppression.
- 3. The nature of the offense and the circumstances under which it was committed are to be considered.
- 4. The ability to make bail is to be regarded, and proof may be taken upon this point.
- 5. The future safety of a victim of the alleged offense and the community shall be considered

The district attorney's office answered two identical requests for information this year regarding the number of defendants out on felony bail by offense and by court. The two requests were for the beginning of February and the beginning of November. In total, Harris County went from 53,830 defendants out on felony bail in February to 55,848 in November.

Looking at offenses, it's noteworthy the number of defendants out for murder/capitol murder is increasing by approximately 2 per week. Also noteworthy is that the change in number of defendants out on felony bail for prostitution has increased from 413 to 611 in the past eight months, suggesting the efforts by Councilman Pollard and Commissioner Ramsey are having an impact.

# Holiday Safety Tips From HPD

With the holiday season upon, most people are preoccupied with the details of holiday plans and shopping. Unfortunately, the safety precautions we normally take are sometimes forgotten, or the excitement of the season causes us to let down our guard. The Houston Police Department wants you to have a SAFE and joyous holiday season so we are reminding you of the following safety tips.

## AT HOME

- •Lock doors and close windows when you leave your house, even if it's only for a minute.
- •When leaving home for an extended period of time, have a neighbor or family member watch your house, pick-up your mail and newspapers, or you can put a hold on mail and newspaper delivery.
- More and more purchases are made on-line so if you are expecting a package and are not going to be home, track your packages on-line, ask a neighbor to pick it up for you or request a signature for proof of delivery to ensure that someone is home. Research your delivery options.
- Thieves usually don't approach homes that appear to be occupied. Indoor and outdoor lights should be on an automatic timer so it appears someone is at home. Put timers for lights in different rooms and have them come on and go off at different times.
- •Large displays of gifts should not be visible from the windows and doors of your home. Do not put out boxes from either large or small purchases on or before garbage day. Doing this allows others to see what new things you have in your home.
- If someone knocks on your door that you do not know, don't answer it. Speak through the door to let them know you're home. Teach your children to do the same thing, but to never let the stranger know they're home alone. Tell them to say their parents are busy and can't come to the door. If they seem suspicious, call 9-1-1 immediately.

• Don't leave keys hidden outside or in fake concealment rocks. Burglars often know how to spot the most common hiding places quickly.



## WHILE SHOPPING

- Stay alert to your surroundings and the people around you. Trust your instincts; if something doesn't feel right, it's probably not call 9-1-1.
- Shop with a friend; there is safety in numbers.
- Avoid carrying large amounts of cash. Pay for purchases with a check, credit, or debit card.
- •Do not leave your purse/wallet in shopping carts. Do not carry wallets in a back pocket. It should be placed in a front pocket for safety.
- •Be alert, criminals look for the "high dollar store" shopping bags with your purchases. When possible, slip bags/ purchases in a plain nondescript bag. Watch purchases while eating in mall food courts; bags as well as purses can easily be switched or taken.
- Avoid overloading yourself with packages. It is important to have clear visibility and freedom of motion to open car doors, etc. When possible have your packages sent to package pick-up where you may retrieve them in a well-lit and heavily populated area.
- •Get keys out of your pocket/purse before leaving the store. Do not leave packages in the vehicle. If changing locations, put them in the trunk BEFORE you leave one destination and get to the other.
- •Be watchful if you observe anyone following you in the parking lot or in a vehicle once you leave the store location. Shop early and leave early to avoid evening darkness and park in a high visibility and well lit area as close to the store as possible. Put all personal valuables out of sight before going out to shop.
- If you feel uncomfortable, ask the Security Officer to escort you to your vehicle. Walk briskly, confidently and directly through the parking lot. Do not be distracted by talking or looking at your cell phone. Be cautious of people handing out fliers or asking questions in the parking lot. Watch for people who may be following you inside as well as outside the store. If you suspect you are being followed, report it immediately to store security

### HOW WE BECAME SHARPSTOWN-IANS

In 1969, I was working as a disc jockey at a radio station in Dallas. I was offered a job in Houston and we moved here with our nine week

old daughter on Labor Day weekend. The station paid for the move so I called a moving company that had been one of the advertisers on my show in Dallas. Their commercials emphasized how they moved your belongings as if they were their own. They even trained the movers, they said, to practice using egg cartons to make sure that nothing would break. Since we were moving from a furnished apartment, my only belonging as far as furniture went, was a tall bookcase. Everything else was

boxes of dinnerware, linens, records, books, stuff in general We stayed with my uncle and aunt when we arrived and I contacted an apartment locator service. My new radio job was in what would become the Galleria area and none of the apartments there accepted kids. An agent lady wanted to show us a place on Mullins and asked us to meet her there. It was then that I discovered one of the peculiarities of Houston. Mullins is not one street, but six separate, unconnected streets with the same name. By the time I finally found the part where the apartment was the locator lady had long since given up and left. Cell phones were years in the

We finally found a spacious one bedroom apartment near Bellaire and Hillcroft with a section in the back for families. I also discovered that furnished apartments in Houston were rare or even non-existent.

Before I was married, I had lived in three apartments in Dallas, all furnished. In fact, the landlord in the last one was always asking us if we wanted another chair or end table that he didn't have room to store. We rented the bare minimum items of furniture and told the moving company we were ready for delivery. Apparently, the egg carton trained guys were on another job that day, because the driver told me, candidly, that he usually picked up someone off the street when he arrived in the destination city as a helper, but that day his wife was available. When he put my only-piece-offurniture bookcase on the two-wheeler, it caught on the ramp and the bookcase did a perfect swan dive headfirst into the parking lot. When I contacted the moving company about a damage claim,



it was covered, but the deductible, of course, was more than the damage.

We settled in and welcomed another daughter the next year. Her expenses would have been covered by my insurance, except the new radio station decided that, although I was doing a good job, the new program director really wanted someone else to do it. That's the way radio is, so the hospital

and doctor were paid out of pocket and there wasn't much there to begin with. A two bedroom in the same complex became available, but only after a third daughter arrived. It was time for a house.... More to come in the next issue!

### RECYCLING THE RIGHT WAY

The City of Houston publishes a trash and recycling collection schedule but there are circumstances that often alter this schedule. Leave your container out and the next day is usually catch up day. If in doubt, call 311 or Scott at the SCA office for information. Here's a quick refresher on what to place in your GREEN curbside recycling bin and what goes in the black curbside trash container. Put these items in your GREEN Bin (make sure you empty and rinse plastic, metal, glass and coated containers).



METAL AND CANS PLASTICS #1-5

CARDBOARD & PAPER & CARTONS NEWSPAPER

#### METAL and CANS:

Aluminum and Tin Cans (rinsed drained)

#### PLASTICS:

Plastic Containers #1 - 5 and 7 (rinsed drained)

#### CARDBOARD and CARTONS:

Carton - Cardboard boxes and cartons from items such as milk, juice, soup, crackers, cream, beans, water, broth, wine, etc.

#### PAPER:

Paper. Newspaper, Catalogs, Magazines and Phone Books

Effective immediately, glass is accepted in the green curbside recycling bin.

## Please don't put dirty paper (greasy pizza boxes), large plastic items like old toys, or plastic bags in the green bin!

These items clog the machinery used to process recyclables resulting in delays and expense.


Section 1 & 2 - Heavy Trash on Tuesday (second Tuesday of every month)

You may place waste at the curb no earlier than 6:00 pm on the Friday prior to collection.

#### How to set out your garbage and recycling:

- City-provided containers must be placed at the curb between 6 p.m. the day before and 7 a.m. on the scheduled collection day.
- Container must face the street with handle facing house.
- Containers must be accessible and not blocked by obstacles, including parked cars, trees, mailboxes, fencing etc. Blocked containers will not be emptied.
- Leave at least a 3ft space between garbage and recycling container. This allows the truck to operate safely.
- Containers must be removed from the curb line and/or public view by 10:00 p.m. on the day of collection and stored in a secure location.
