Beginning in late May, many of you received a postcard inviting you to go online to learn more about the proposal to update Sharpstown's deed restriction and to approve the change for your section. For those who did just that – YOU ROCK!

This process is very important for Sharpstown. The proposed changes began in 2019 with many iterations resulting from residents' feedback. All the changes now proposed to our 60-70 year old deed restrictions are designed to improve our community and ensure that Sharpstown will thrive and maintain its value in the future. Equally important, the changes will make our deed restrictions enforceable and compliant with current laws.

Adopting mandatory dues and becoming a 209 entity was a tough decision but as we debated the pros and cons, it was clearly the right direction. We have resisted debating these complex issues online or on social media. Those means of communication were not feasible or productive . Sadly, a great deal of false information has been spread in the community. The board does not intend to poo-poo the concerns of our residents, but recognizes that some people may not understand the changes or be fearful of change itself. This won't help move Sharpstown forward.

Board members of the SCA all own homes here and are your neighbors. We are willing to take this leap and ask you do so too. In the next few weeks, you will receive a letter with more information. It's really just a review of what we have been saying and have made available on the SCA website. We want to be sure that all residents have the opportunity to learn and decide whether to support with your approval. This will not be a short-term project. We want to approach the matter thoughtfully and with respect for all viewpoints. Those who feel the changes are not in their best interests, do not need to do anything.

The SCA will provide an update on how the approval process is going later this year. In the meantime, we strongly encourage you to go to our website and learn more.

#### DEFINITIONS OF CRIME TYPES

**Robbery** — the taking of money or goods in the possession of another, from his or her person or immediate presence, by force or intimidation.

**Burglary** — (breaking and entering) an unlawful entry into a building for the purposes of committing an offence. Usually that offence is theft.

**Theft** — the act of stealing; the wrongful taking and carrying away of the personal goods or property of another; larceny. Examples include ransacking unlocked cars, taking property out of open garage doors, taking a purse off a front seat of an unlocked car, taking a mower out of the back of a pickup truck.

**Aggravated Assault** — an attempt to cause serious bodily injury purposely.

**Property Crime** — destruction, damage, vandalism

**Rape** — unlawful sexual activity carried out against the will of a male, female, or person under age, or incapable of consent.

District J Patrol strives to bridge the gap between the law enforcement officers in District J and the communities they serve. Residents may report small neighborhood


#### NATIONAL NIGHT OUT 2022 TUESDAY OCT 4 6-9 PM


Here is a guide to what is and is not allowed in Sharpstown.

We are spending more than we take in on enforcing Deed Restrictions - our most important legal duty.

Deed Restriction enforcement and maintaining Architectural Controls is why the SCA exists legally. If the SCA is not able to get a homeowner to comply then we must engage with our attorney unfortunately. We do this only as a last resort and usually many months or even years will have passed before we resort to this because of the cost. However, the chart above shows what we have spent of our dues on this process and also what we have been able to recoup from legal cases being awarded in the SCA's favor with judgments and reimbursements. Being good stewards of SCA \$ is the board's constant priority.



# DO YOU KNOW YOUR DEED RESTRICTIONS?

Remodeling your home? Adding On? Do you know your deed restrictions? Did you know that the Sharpstown Civic Association can look over your proposed plans for free before you start construction? We want to avoid deed restriction violations before they happen. Did you know that we have a 25 foot rear setback for the main structure? Did you know that there is a minimum percentage of brick that must be on your home? Did you know that you can't build in front of your building line? We want to help you! We want you to find out about possible violations before it costs you money and time. Several homeowners in the past couple years have had to tear down and/or modify their construction due to deed restriction violations. The City of Houston does not review deed restrictions when issuing permits. They require a signed affidavit acknowledging that the plans comply with your deed restrictions. This holds YOU, the homeowner, accountable for knowing and complying with your deed restrictions. We are here to help you. #### STORM DRAIN PROBLEMS

If you have a storm drain in front of your house, please check to see if it has any debris. It doesn't matter whether it is leaves, pine needles, or trash--pick it up and throw it away. Don't let it flow into the storm drain and become part of a bigger problem.



#### LEWIS GAMMON -SCA SUPPORTER AND LONG TIME RESIDENT

August 15, 1922 - April 30, 2022

Lewis E. Gammon completed what he called his "journey down the road of life". Lewis was an incredible man inspiring us



A Celebration of Life and Memorial was held on August 13, 2022. Lewis passed away on April 30 a few months shy of his birthday and the family decided to keep his centennial birth date weekend special. Internment with military honors was held May 18 at Houston National Cemetery.

Lewis' full story is available on Legacy.com's site. In my infancy of civic involvement with the SCA Lewis was one of my greatest joys. Lewis rarely missed an SCA monthly meeting or event. He often would ask a question when we had a speaker and I eagerly awaited his every word. He would stand slowly, and address the speaker as "Mr Speaker" and then ask his question in a very eloquent way. He always had a compliment or was quick to give recognition to anyone. I also have fond memories of Lewis attending the Schiller Institute choir concerts. Often, he was the only face I recognized and his smile made me think he was there supporting just me! #### HOW WE BECAME SHARPSTOWN-IANS - CONTINUED ...


I grew up in Fort Worth on Foard street, which meant I always had to spell it out for people who asked my address. It was named, like most of the streets in that neighborhood, for a county in northwest Texas, not Henry's car company. So, since we moved to our house on Galleon Drive, all of a five-block drive, I have had to spell that name for people. I tried saying, "Like a Spanish Galleon", but after many, "What is that?" questions, I just spell it.

I have wondered, in a couple of Facebook posts, if anyone knows how Sharpstown streets were named, besides the obvious Sharpview and Sharpcrest. Many streets in Bellaire are named for plants or trees, Elm, Pine, Maple, Beech for example, and there is a section off Newcastle with first names of people, Betty, Vivian, Cynthia, Dorothy, but streets in Sharpstown named for things or people seem to be one-off. Galleon is a kind of ship, but there are no other streets named for ships, unless Carvel is a misspelling of caravel, a kind of ship developed by the Portuguese for exploration.

Croton is a flowering plant, but no other plant named streets. Tours is a city in France, but no other French or any other city names. Osage is the name of a Native American tribe of the Great Plains, but no Sioux, Crow, or Comanche streets. Neff Street is named for the 28th governor of Texas, Pat Morris Neff, as is an HISD school.

Several downtown streets are named for governors, Bell, Pease, Runnels, Hamilton and Sul Ross, but no other streets in Sharpstown are named for former Texas governors, unless Mary Bates was a governor that only served for a few hours in 1887. There is a street

called Tarna and another, only one block from Neff called Tarnef, which, I am convinced was somebody's diabolical idea a joke to confuse mail carriers and pizza delivery persons.





And speaking of confusion, see my first article I wrote for SCAN about our first encounter with Houston streets where we were supposed to meet at an apartment on Mullins with an agent from an apartment finder service only to find that Mullins is actually seven separate pieces of roadway, none of which is connected to the other. Rowan, Roos and Stroud, also in several unconnected segments, look for all the world like streets, but are designated as Lane, Road and Drive, respectively. One expects to be able to travel a long way on a "Drive", but one could scarcely reach the speed limit on Stroud Drive without running out of roadway, while Beechnut and Bissonnet, which stretch nearly across half of Houston are called "streets." Bellaire is properly called a boulevard. Mary Bates is also called a boulevard, but clearly isn't. And, by the way, there are no houses facing Verlie Lane, so it has no addresses.

If you call me and ask how to spell the name of my street, I'll tell you, "It's Galleon. Look it up.".

#### TREES OF SHARPSTOWN

In the last issue, we highlighted the Ornamental Pear.

Although mentioned in the article, I was reminded that these trees are considered invasive. However, it is the goal of these articles to help you identify some of the trees in our neighborhood—in fact, the parking lot at Father Pickard/ Lansdale Park, has several Ornamental Pear trees near the entrance.



Speaking of invasive trees, it's time to mention the Tallow Tree. Brought to the US from Asia, these trees were originally considered ornamental, but they now infest more than 234,000 acres in southeast Texas. They establish easily, grow quickly, and produce large quantities of seeds, many of which are spread by birds, animals, and water throughout the area. These trees cause problems in bayous, irrigation systems, drainage ditches, rights-of-way, vacant lots, and our own lawns. If you remove a Tallow Tree, but leave some of the root, it will grow back. If you have a Tallow Tree in your lawn, you have probably noticed that it produces lots of babies from those roots. Add to that the fact that the branches droop and break easily, and you quickly realize that this tree creates a lot of work.

Because this is a non-native tree, if you're interested in planting a new tree in your lawn, there are many other trees which should be considered and will do well.



#### RECYCLING THE RIGHT WAY

The City of Houston publishes a trash and recycling collection schedule but there are circumstances that often alter this schedule. Leave your container out and the next day is usually catch up day. If in doubt, call 311 or Scott at the SCA office for information. Here's a quick refresher on what to place in your GREEN curbside recycling bin and what goes in the black curbside trash container. Put these items in your GREEN Bin (make sure you empty and rinse plastic, metal, glass and coated containers).











PAPER &

NEWSPAPER

#### **METAL and CANS:**

METAL AND CANS

Aluminum and Tin Cans (rinsed drained)

#### PLASTICS:

Plastic Containers #1 - 5 and 7 (rinsed drained)

#### CARDBOARD and CARTONS:

Carton - Cardboard boxes and cartons from items such as milk, juice, soup, crackers, cream, beans, water, broth, wine, etc.

#### PAPER:

Paper, Newspaper, Catalogs, Magazines and Phone Books



#### GLASS:

Effective immediately, glass is accepted in the green curbside recycling bin.

Please don't put dirty paper (greasy pizza boxes), large plastic items like old toys, or plastic bags in the green bin!

These items clog the machinery used to process recyclables resulting in delays and expense.


Section 1 & 2 - Heavy Trash on Tuesday (second Tuesday of every month)

You may place waste at the curb no earlier than 6:00 pm on the Friday prior to collection.

#### TRASH FACTS



#### How to set out your garbage and recycling:

- · City-provided containers must be placed at the curb between 6 p.m. the day before and 7 a.m. on the scheduled collection day.
- Container must face the street with handle facing house.
- Containers must be accessible and not blocked by obstacles, including parked cars, trees, mailboxes, fencing etc. Blocked containers will not be emptied.
- · Leave at least a 3ft space between garbage and recycling container. This allows the truck to operate safely.
- Containers must be removed from the curb line and/or public view by 10:00 p.m. on the day of collection and stored in a secure location.


