In 2023 we will publish our 47th volume, having proudly served the Sharpstown community for four decades. The SCAN is now provided in full color with high-resolution photos and graphics. It is the primary source of news and information for residents of the 6800 homes inside Sharpstown's boundaries. Delivered by the US Postal Service, SCAN circulation is estimated at 7,000 with pass-along readership estimated at 12,000 to 15,000.
